

## KEY INVESTOR INFORMATION

## Objectives and Investment Policy

This Fund is actively managed and aims to achieve long term capital growth from equity exposure in a) Emerging Markets including the wider BRIC countries region (Brazil-Russia-India-China) and b) Frontier Markets (see Note below) and/or in stocks of companies incorporated, listed or traded in any other stock exchange but which derive a significant portion of their revenues from the above markets or are holding significant interest in such companies.

The Fund will invest its assets primarily in units of UCITS and/or other UCIs. Investment exposure in Frontier Markets may not exceed 30% of the Fund's total net assets. In case where indirect investments through units of UCITS and/or UCIs are not possible or are too costly, the Fund can directly invest in stocks and other similar instruments of companies as described in the first paragraph listed or traded in Officially Regulated Local and/or International stock exchanges. Such direct investments cannot exceed 20% of the Fund's total net assets. Also the Fund may invest directly, up to 50% of its total net assets, in bank deposits and money market instruments. Selection of the underlying funds is based on a quantitative and qualitative analysis on a frequent ongoing basis in order to contribute positively in the funds' objective.

The Fund can use derivatives to reduce the impact of market changes or changes in currency exchange rates on its performance.

You can buy or sell shares of the Fund on a daily (bank business days in Luxembourg and Greece) basis.

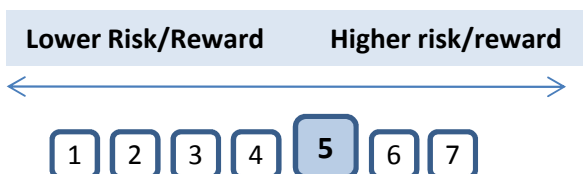
All income of the Fund is reinvested.

Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within 3 years.

**Note:** Frontier Markets is an economic term which was originally used by International Finance Corporation in 1992. It is more often used to describe a subset of emerging markets (EMs), which have market capitalizations that are small and/or low annual turnover and/or market restrictions unsuitable for inclusion in the larger EM indexes but nonetheless have demonstrated a relative openness to and accessibility for foreign investors and are not under extreme economic and political instability, although such a risk may not be excluded. Some indicative list of names of countries included in such definitions are: Argentina, Bahrain, Bangladesh, Botswana, Bulgaria, Côte d'Ivoire, Croatia, Cyprus, Estonia, Jordan, Kazakhstan, Kenya, Kuwait, Lebanon, Lithuania, Malta, Mauritius, Nigeria, Oman, Pakistan, Romania, Serbia, Slovakia, Slovenia, Sri Lanka, Trinidad and Tobago, Tunisia, Ukraine, Vietnam.

## Risk and Reward Profile

**Why is this Fund in category 5?** The Fund is classified in the specific category because its share price may fluctuate moderately comparative to higher or lower categories classifications. Therefore the likelihood of bigger losses or gains is comparatively moderate.

The Risk / Reward profile is a reasonably accurate reflection of the risk inherent in the Fund under past market & operational conditions. As regards potential future extraordinary events different from those occurred in the past history of the Fund, these are not captured by the Risk / Reward profile; other risks not captured by it include -the risk due to operational failure, i.e. human error or failure in systems and processes, -the risk due to unforeseeable unusually big orders by clients to exit the Fund, which may result in worse than expected entry/exit price levels, -in cases that the Fund invests in derivatives, mainly the risk of failure of derivative counterparties to fulfill their obligations, -the risk carried by the fact that emerging countries' capital markets are smaller, less liquid and more volatile than developed countries' capital markets.

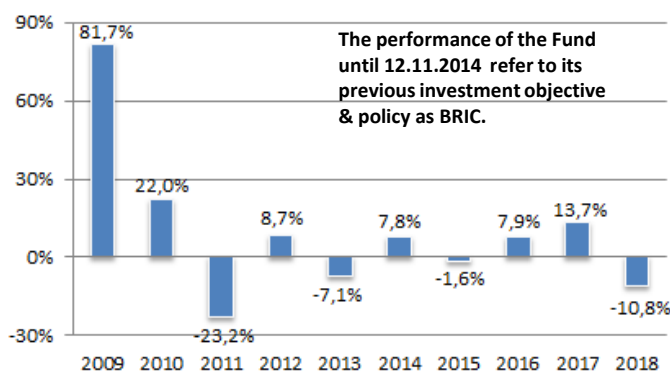
The entry and exit charges shown are maximum figures and in some cases you may pay less. You can find out the actual charges from your financial advisor or distributor.
