**What is this product?**

**Type:** This product is a class of units of the Sub-Fund and denominated in EUR. The Fund is a mutual investment fund ("fonds commun de placement") and qualifies as an Undertaking for Collective Investments in Transferable Securities ("UCITS"), organized under Part I of the Luxembourg law of 17 December 2010 on undertakings for collective investments ("Investment Fund Law"), transposing Directive 2009/65/EC related to UCITS.

**Term:** The Sub-Fund has been established for an unlimited period of time.

**Objectives:** This Sub-Fund aims to achieve long term capital growth from equity exposure in a) Emerging Markets including the wider BRIC countries region (Brazil-Russia-India-China) and b) Frontier Markets and/or in stocks of companies incorporated, listed or traded in any other stock exchange but which derive a significant portion of their revenues from the above markets or are holding significant interest in such companies.

Investment exposure in Frontier Markets may not exceed 30% of the Sub-Fund's total net assets. In case where indirect investments through units of UCITs and/or UCIs are not possible or are too costly, the Sub-Fund can directly invest in stocks and other similar instruments of companies as described in the first paragraph listed or traded in Officially Regulated Local and/or International stock exchanges. Such direct investments cannot exceed 20% of the Sub-Fund's total net assets. Also the Sub-Fund may invest directly, up to 50% of its total net assets, in bank deposits and money market instruments. Selection of the underlying funds is based on a quantitative and qualitative analysis on a frequent ongoing basis in order to contribute positively in the funds' objective. The Sub-Fund can use derivatives to reduce the impact of market changes or changes in currency exchange rates on its performance.

This product does not have the objective of sustainable investment or binding environmental or social characteristics as defined by Regulation (EU) 2019/2088 on Sustainability-related Disclosures in the Financial Services Sector (the "SFDR"). The Sub-Fund is actively managed which means that the investment manager is actively making investment decisions for the Sub-Fund. The Sub-Fund is not managed in reference to a benchmark.

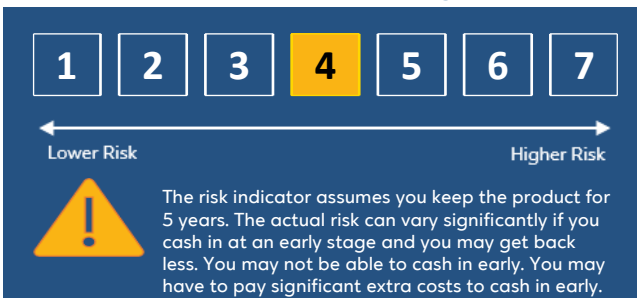
You can buy or sell shares of the Sub-Fund on a daily (bank business days in Luxembourg and Greece) basis. All income of the Sub-Fund is reinvested.

**What are the risks and what could I get in return?**



**Risk Indicator**

The Product is classified in the specific category because its share price may fluctuate moderately comparative to higher or lower categories classifications. The unfavourable scenario occurred for an investment between 27/02/15 - 29/02/16 (if you surrender after 1 year) and between 30/06/21 - 29/12/23 (if you surrender after 5 years). The moderate scenario occurred for an investment between 30/11/15 - 30/11/16 (if you surrender after 1 year) and between 30/06/17 - 30/06/22 (if you surrender after 5 years). The favourable scenario occurred for an investment between 31/03/20 - 31/03/21 (if you surrender after 1 year) and between 29/02/16 - 26/02/21 (if you surrender after 5 years).

## What happens if Eurobank Fund Management Company (Luxembourg) S.A. is unable to payout?

The assets of the Fund constitute independent assets, distinct in all respects from the assets of the Management Company. The assets are kept by its Depository, "Eurobank Private Bank Luxembourg S.A.". In case of insolvency of the Management Company, the assets of the UCITS, the safekeeping of which has been assigned to the custodian, will not be affected. There is no compensation or guarantee scheme in place which may offset all or any such loss.

## What are the costs?

### Costs over time
